After agreeing on your tentative date and time, <u>contact all residents on the street whose</u> <u>property will be affected by the blocking.</u> Have those property owners sign their name and <u>address on page two (2) of the form, giving permission for the blocking on the date and times indicated.</u> No block party will be permitted to extend past 11:00 p.m.

The list of signatures must be submitted to the City Administrative Office no later than two (2) business days prior to the event. Names will be checked and the Police and Fire Departments will be notified of your event. All residents on your street should be made aware of the necessity to provide access for emergency vehicles should that need arise.
